

# THE CORPORATION OF THE VILLAGE OF KEREMEOS

## Bylaw No. 789, 2011

### Being a bylaw for the levying of taxes for Municipal, Regional District, Regional Library and Regional Hospital purposes for the Year 2011

---

**Municipal Council of the Corporation of the Village of Keremeos, in open meeting assembled, enacts as follows:**

1. This bylaw may be cited for all purposes as "Village of Keremeos Tax Rates Bylaw No. 789, 2011".
2. The following rates are hereby imposed and levied for the year 2011:
  - (a) For all lawful general purposes of the municipality on the value of land and improvements taxable for general municipal purposes, rates appearing in column "A" of the "Schedule" attached to and forming a part of this bylaw; and
  - (b) For debt purposes on the value of land and improvements taxable for general municipal purposes, rates appearing in column "B" of the "Schedule" attached to and forming part of this bylaw; and
  - (c) For purposes of the Regional District of Okanagan-Similkameen on the value of land and improvements taxable for Regional Hospital District purposes, rates appearing in column "C" of the "Schedule" attached to and forming part of this bylaw; and
  - (d) For purposes of the Regional District of Okanagan-Similkameen for the 911 Emergency System, Recreation Centre, Swimming Pool and Refuse Disposal Site, on the value of improvements taxable for Regional Hospital District purposes, rates appearing in column "D" of the "Schedule" attached to and forming part of this bylaw; and
  - (e) For purposes of the Regional District of Okanagan-Similkameen for the Sterile Insect Release Program, on the value of land taxable for Regional Hospital District purposes, rates appearing in column "E" of the "Schedule" attached to and forming part of this bylaw; and
  - (f) For purposes of the Okanagan-Similkameen Regional Hospital District on the value of land and improvements taxable for Regional Hospital District purposes, rates appearing in column "F" of the "Schedule" attached to and forming part of this bylaw; and

- (g) For the purposes of the Okanagan Regional Library District on the value of land and improvements taxable for general municipal purposes, rates appearing in column "G" of the "Schedule" attached to and forming part of this bylaw.


3. The minimum amount of taxation upon a parcel of real property shall be One Dollar (\$1.00).


